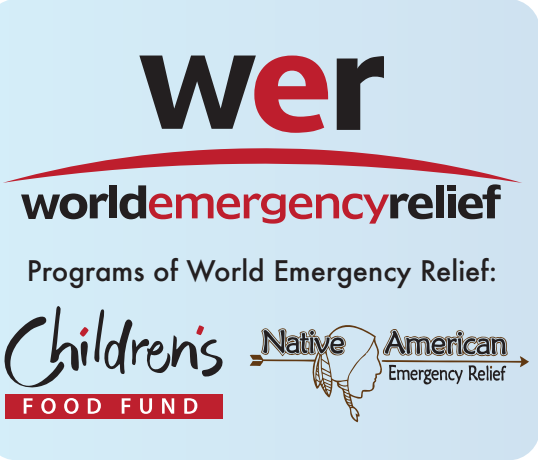

WER/NAER remains committed to excellence in quality of program and management of the funds entrusted to us by our donors. In 2022, we used 98.7% of all donated resources for program expenses. Of our remaining total revenue, only 0.8% was used for fundraising and 0.5% for management costs such as staff salaries and office operating expenses. Our dedicated Board, staff and community volunteers understand that our donors place a special trust and confidence in our stewardship of their donated resources.

Our commitment to improving children's lives continues through our two primary outreaches, **Native American Emergency Relief & Children's Food Fund**. NAER's focus is to improve the lives of Native American's by providing food, blankets, firewood, water barrels and agricultural support. CFF programs concentrate on feeding children and providing resources for their basic needs.

Through these programs, WER provided over **\$37 million** in food, medicines, hygiene and disaster relief supplies to people in need.

In 2022, our faithful donors helped us to:

- Deliver over 2.4 million pounds of fresh produce and non-perishable foods plus warm blankets, firewood, and water barrels to Native American families.
- Provide life-saving food for over 56,000 African families.
- Ship over \$10 million in urgent relief supplies to Ukraine.
- Respond to a record number of disasters – providing hope, healing and emergency relief to our fellow Americans in their time of need.
